3.216 Acres, situated in **O.T. Tyler Survey, Abstract 20**, Bell County, Texas, being a portion of a tract of land described in that certain "Assignment, Bill of Sale, & Assumption Agreement by and between Georgetown Railroad Company, a Texas corporation and the City of Temple, a home rule city (Assignee), in Document No. 2011-00009397, Official Public Records of Real Property, Bell County, Texas, and being more particularly described as follows:

BEGINNING at a 5/8" iron rod found on the south line of said City of Temple tract, being the northwest corner of a called 36.326 acre tract conveyed to Belton Economic Development Corporation in Document No. 2016-00034242, of said official public records, same being the northeast corner of a called 2.55 acre tract conveyed to Bell MM Enterprises, LLC, a Texas limited liability company in Volume 5033, Page 670, of said official public records, for the southwest corner of this tract of land;

THENCE, in a northerly direction, over and across said City of Temple tract, **N 26°18'12" E., 77.53 feet**, to a 5/8" iron rod with cap stamped "ACS" set on the south line of Taylors Valley Road, according to Volume 685, Page 567, Deed Records of Bell County, Texas, same being the north line of said City of Temple tract, for the northwest corner of this tract of land;

THENCE, in an easterly direction, with the south line of said Taylors Valley Road, same being the north line of said City of Temple tract, the following courses and distances follow:

1. **S 64°40'52" E., 90.90 feet**, (*Deed S 62°15' E., 605.8 feet – Vol. 685, Pg. 567*), to a 5/8" iron rod with cap stamped "ACS" set;
2. **S 66°08'52" E., 268.60 feet**, (*Deed S 63°43' E., 268.6 feet – Vol. 685, Pg. 567*), to a 5/8" iron rod with cap stamped "ACS" set at the beginning of a curve to the left;
3. With said curve to the left, an arc distance of **43.90 feet**, a radius of **1186.30 feet**, a delta angle of **2°07'14"**, and a long chord which bears **S 67°11'00" E., 43.90 feet**, to a 5/8" iron rod with cap stamped "ACS" set at the northwest corner of a tract of land conveyed to SMA Family Partnership in Document No. 2007-00052722, of said official public records, and described in Volume 723, Page 188, of said deed records, for a corner of this tract of land;

THENCE, in a southerly direction, with the west line of said SMA tract, same being an east line of said City of Temple tract, **S 19°07'27" W., 6.35 feet**, (*Deed S 21°30' E., 6.25 feet – Vol. 723, Pg. 188*), to a 5/8" iron rod with cap stamped "ACS" set at the southwest corner of said SMA tract, same being an interior corner of said City of Temple tract, for an interior corner of this tract of land;

THENCE, in an easterly direction, with the south line of said SMA tract, same being the north line of said City of Temple tract, **S 64°31'57" E., 1229.11 feet**, (*Deed S 62°30' E., 1235 feet – Vol. 723, Pg. 188*), to a calculated point in a building on the south line of a called 8.57 acre tract conveyed to Belco Manufacturing Company, Inc., in Document No. 2007-00048216, of said official public records, for the northeast corner of this tract of land;

THENCE, in a southerly direction, over and across said City of Temple tract, **S 25°22'44" W., 103.05 feet**, to a 5/8" iron rod found at the northeast corner of said 36.326 acre tract, same being the northwest corner of a called 18.952 acre tract conveyed to SMA Family, Ltd., in Volume 5316, Page 598, of said official public records, for the southeast corner of this tract of land;

THENCE, in a westerly direction, with the north line of said 36.326 acre tract, same being the south line of said City of Temple tract, the following courses and distances follow:

1. **N 62°23'48" W., 182.68 feet**, (*Deed N 62°22'32" W., 182.65 feet – Doc. No. 2016-00034242*), to a 5/8" iron rod found;
2. **N 65°14'51" W., 441.03 feet**, (*Deed N 65°16'34" W., 440.87 feet – Doc. No. 2016-00034242*), to a 5/8" iron rod with cap stamped "ACS" found;
3. **N 53°12'34" W., 158.45 feet**, (*Deed N 53°07'43" W., 158.74 feet – Doc. No. 2016-00034242*), to a 60d nail found;
4. **N 65°13'47" W., 855.50 feet**, (*Deed N 65°14'10" W., 856.34 feet – Doc. No. 2016-00034242*), to the **Point of Beginning** and containing 3.216 acres of land.
