A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING THE PURCHASE AND INSTALLATION OF PLAYGROUND EQUIPMENT FROM CUNNINGHAM RECREATION OF CHARLOTTE, NORTH CAROLINA IN THE ESTIMATED AMOUNT OF \$139,733.40; AND PROVIDING AN OPEN MEETINGS CLAUSE.

**Whereas**, this item will allow for the purchase and installation of playground equipment from Cunningham Recreation of Charlotte, North Carolina for Colquitt Park, located at 3510 Hickory Road - this project includes a steel playground recommended for ages two through five, a two-bay swing set, multiple spring riders, poured-in-place rubber surfacing beneath the play unit, and engineered wood fiber beneath the swings;

**Whereas**, Cunningham Recreation has been awarded Contract No. 2017001134 by OMNIA, which Staff is recommending using for this purchase - contracts awarded by OMNIA have been competitively procured and meet the statutory procurement requirements for Texas municipalities;

**Whereas**, delivery and installation of the playground equipment is expected to be complete in six to 12 weeks;

**Whereas**, Staff recommends Council authorize the purchase and installation of playground equipment from Cunningham Recreation in the estimated amount of \$139,733.40;

**Whereas**, funding for this purchase and installation from Cunningham Recreation in the amount of \$139,733.40 is available in Account No. 362-3500-552-6516, Project No. 103235; and

**Whereas**, the City Council has considered the matter and deems it in the public interest to authorize this action.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:**

**Part 1: Findings.** All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Temple, Texas, and they are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.

**Part 2:** The City Council authorizes the purchase and installation of playground equipment from Cunningham Recreation of Charlotte, North Carolina in the estimated amount of \$139,733.40, and authorizes the City Manager, or her designee after approval as to form by the City Attorney's Office, to execute any necessary documents.

**Part 3:** It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
