AFFIDAVIT

I am the same T. M. MOORE that bought various tracts of land out of the Nancy Chance League Survey in Bell County, Texas from Fred H. Ferguson, Jr. and wife Grace, Reba C. Fisher and husband Robert, and Roy E. Ferguson and wife Ruth in 1946. This conveyance is recorded in the Bell County Deed Records in Volume 548, Page 237. This sale was negotiated by a real estate agent named Cloud.

The tract of land which is described in Exhibit "A" attached hereto and is made a part hereof was not described in the above referenced deed. However, it was the intention of Mr. Fred Ferguson's heirs to convey to me all the tracts of land in this area north of the railroad tracks that they owned.

This tract of land was once owned by A. F. Bentley and conveyed to F. H. Ferguson. No deed was recorded in Bell County evidencing this conveyance, but Mr. Ferguson held the property for many years and mined the gravel on the property.

Since I purchased the tract in 1946, I have never had any boundary dispute with my neighbors or squatters in connection with this tract. I have been living all this time not over one mile from the tract.

THENCE S. 73° 14' 46" W. , 109.35 feet with the south line of Pepper Creek to an iron pipe for the northwest corner of this.




