A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, RATIFYING THE PURCHASE OF ONE 2024 DIESEL-POWERED FRONT LOAD REFUSE TRUCK FROM VOLVO & MACK TRUCKS OF WACO IN THE ESTIMATED AMOUNT OF \$379,396.20; DECLARING AN OFFICIAL INTENT TO REIMBURSE THE EXPENDITURE WITH THE ISSUANCE OF 2025 LIMITED TAX NOTES; AND PROVIDING AN OPEN MEETINGS CLAUSE.

Whereas, this item will ratify the purchase of a diesel-powered front load refuse truck from Volvo & Mack Trucks of Waco (Volvo & Mack) as approved in the budget - the purchase is for one 2024 Mack diesel-powered chassis with Wittke FEL body that is an addition to the fleet to support ongoing solid waste operations;

Whereas, Volvo & Mack has been awarded Contract No. 230802 by The Interlocal Purchasing System (TIPS), which Staff is recommending using for this purchase - contracts awarded by TIPS have been competitively procured and meet the statutory procurement requirements for Texas municipalities;

Whereas, this truck will replace existing Asset No. 14953, a 2019 CNG-powered front load that will become a spare and allow for the auction of Asset No. 13686, a 2013 model - the front loader refuse truck was delivered in December 2024;

Whereas, Staff recommends Council ratify the purchase of one 2024 diesel-powered front load refuse truck from Volvo & Mack in the estimated amount of \$379,396.20, as well as declare an official intent to reimburse the expenditure with the issuance of 2025 Limited Tax Notes;

Whereas, this front load refuse truck is being funded with the issuance of the 2025 Limited Tax Notes and the City is declaring an official intent to reimburse for this purchase - a budget adjustment will be prepared at the time of the sale to reimburse expenditures incurred prior to the issuance of the limited tax notes;

Whereas, funding for this purchase from Volvo & Mack in the amount of \$379,396.20 will be available in Account No. 364-2300-540-6222, Project No. 103440; and

Whereas, the City Council has considered the matter and deems it in the public interest to authorize this action.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:

Part 1: Findings. All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Temple, Texas, and they are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.

Part 2: The City Council ratifies the purchase of one 2024 diesel-powered front load refuse truck from Volvo & Mack Trucks of Waco in the estimated amount of \$379,396.20, declares an official intent to reimburse the expenditure with the issuance of 2025 Limited Tax Notes, and authorizes the City Manager, or her designee, after approval as to form by the City Attorney's Office, to execute any necessary documents.

Part 3: It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
