ITEM DESCRIPTION: Consider adopting a resolution appointing members to various City Boards and Commissions.

Planning and Zoning Commission: Re-appoint Becky Krause and Ryan Smith to fill expired terms ending September 30, 2027, appoint Greg Rhoads to fill an expired term ending September 30, 2027 and appoint Alexis Prager to fill an unexpired term ending September 30, 2025.

Tax Increment Financing Reinvestment Zone No. 1 Board: Re-appoint Tyler Johnson, Thomas Cloud, Lester Fettig, John Kiella and Gary Schmidt to fill expired terms ending September 30, 2026 and appoint Rob Marshall and Lacy Wagoner to fill expired terms ending September 30, 2026.
