A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING THE PURCHASE OF AN ANNUAL SOFTWARE SUBSCRIPTION FOR CITYWORKS ASSET MANAGEMENT AND WORK ORDER SOFTWARE FROM AZTECA SYSTEMS, LLC OF SANDY, UTAH IN THE ESTIMATED AMOUNT OF \$70,106.40; AND PROVIDING AN OPEN MEETINGS CLAUSE.

Whereas, the City of Temple implemented Cityworks asset management and work order software (Cityworks AMS) from Azteca Systems, LLC (Azteca) of Sandy, Utah for the Public Works and Airport Services Departments;

Whereas, Cityworks is uniquely designed to utilize the Geographic Information System (GIS) geodatabase to identify and track the location of the City's infrastructure assets, such as water and wastewater lines, streets, and drainage structures - though other approaches may interface with GIS, generally for map visualization, Cityworks utilizes the GIS geodatabase to track the asset inventory;

Whereas, Cityworks leverages the inherent value of a GIS-centric, enterprise asset inventory by not only managing the assets and their associated attributes such as type, condition, installation date, etc., but also the work done to care for assets - the linkage between assets and work orders is maintained such that the history of completed work orders against a specific asset is viewable and is easily retrieved;

Whereas, this software enables a more efficient workflow, easier navigation, and a fully integrated GIS-centric process, as well as allows Staff to create a customized workflow that will best fit the needs of the City's Public Works and Airport Staff - the software also interfaces to other City systems (e.g., accounting, billing, etc.);

Whereas, Server AMS Standard Enterprise License Renewal includes unlimited quantities of the identified products: Office, Field, Respond, Mobile Native apps (for iOS and Android), and also includes the following add-ons: Storeroom, Equipment Checkout, Contracts, Cityworks Analytics for AMS, Cityworks for Excel, Enterprise URL (eURL), Web Hooks, Web Map Manager, and Local Government Templates (LGT);

Whereas, Azteca is the developer and sole source provider for the maintenance of its product - the term of the subscription will be from October 2, 2024 to October 1, 2025;

Whereas, Staff recommends Council authorize the purchase of an annual software subscription for Cityworks AMS from Azteca in the estimated amount of \$70,106.40; and

Whereas, funding for the purchase of the Cityworks AMS software subscription from Azteca in the amount of \$70,106.40 is included in the Fiscal Year 2025 Budget, as shown below:

Whereas, the City Council has considered the matter and deems it in the public interest to authorize this action.

Part 1: Findings. All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Temple, Texas, and they are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.

Part 2: The City Council authorizes the purchase of an annual software subscription for Cityworks AMS Asset Management and Work Order Software from Azteca Systems, LLC of Sandy, Utah in the estimated amount of \$70,106.40, and authorizes the City Manager, or her designee, after approval as to form by the City Attorney's Office, to execute any necessary documents.

Part 3: It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
