ITEM DESCRIPTION: Consider adopting a resolution authorizing an agreement with Burlington Northern Santa Fe for project inspection of the 24th Street Overpass and Pedestrian Improvements in the estimated amount of \$79,992.

BACKGROUND: As a part of 24th Street Overpass and Pedestrian Improvements, the bridge over the Burlington Northern Santa Fe (BNSF) railroad on 24th Street between Martin Luther King Jr. Boulevard is to be reconstructed to allow for pedestrian improvements as designed by Kasberg, Patrick & Associates, LP (KPA). This includes removing and replacing concrete traffic rails on the outside of the bridge, installation of new walkway protective throw fencing, and re-striping the roadway.

BNSF has prepared an Overpass Agreement in an estimated amount of \$79,992 which outlines the City's and BNSF's responsibilities. Exhibit A – Map and Exhibit B – Estimate are attached for reference.

On December 15, 2022, Council authorized a professional services agreement with KPA to design the 24th Street Pedestrian Facilities. Council authorized contract amendments #1 through #6 for geotechnical investigations, related design changes, bidding and construction phase services. On July 18, 2024, Council authorized a construction award to Patin Construction, LLC for this project.
