A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING AN ANNUAL SERVICES AGREEMENT WITH GREEN WORLD CARE, INC. OF DALLAS, TEXAS FOR MOWING AND MAINTENANCE OF THE CROSSROADS DISC GOLF COURSE AND PEPPER CREEK TRAIL IN THE ESTIMATED AMOUNT OF \$112,445 FOR FISCAL YEAR 2025; AND PROVIDING AN OPEN MEETINGS CLAUSE.

Whereas, this item will allow for a mowing and maintenance services agreement with Green World Care, Inc. (GWC) of Dallas, Texas for mowing and maintenance of approximately 65 acres of the Crossroads Disc Golf Course and Pepper Creek Trail;

Whereas, Request for Proposals No. 35-03-25 was issued to procure the mowing and maintenance services – four proposals were received from Grass Works Lawn Care of Leander, Texas; GWC; Heart of Texas Landscape & Irrigation, Co., Inc. of Belton, Texas; and Yellowstone Landscape of Pflugerville, Texas;

Whereas, an evaluation committee comprised of Parks and Recreation and Finance Staff determined the proposal submitted by GWC will provide the best value for the City - evaluation factors included the proposed pricing; demonstrated understanding of the scope of work and proposed work plan; experience, reputation, and abilities; and quality and quantity of personnel and equipment;

Whereas, the annual contract will commence October 1, 2024 and continue through September 30, 2025 - the contract can be extended for four additional one-year periods, if agreeable to both parties;

Whereas, Staff recommends Council authorize an annual services agreement with GWC for mowing and maintenance of the Crossroads Disc Golf Course and Pepper Creek Trail in the estimated amount of \$112,445 for Fiscal Year 2025; and

Whereas, funding for the annual services agreement with GWC in the estimated amount of \$112,445 is available as follows:

Whereas, the City Council has considered the matter and deems it in the public interest to authorize this action.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:

Part 1: Findings. All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Temple, Texas, and they are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.

Part 2: The City Council authorizes an annual services agreement with Green World Care, Inc. of Dallas, Texas for mowing and maintenance of the Crossroads Disc Golf Course and Pepper Creek Trail in the estimated amount of \$112,445 for Fiscal Year 2025, and authorizes the City Manager, or her designee, after approval as to form by the City Attorney's Office, to execute any necessary documents.

Part 3: It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
