A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING AN INTERLOCAL AGREEMENT WITH THE ACADEMY INDEPENDENT SCHOOL DISTRICT TO PROVIDE DAY CAMPS ON SELECT FRIDAYS THROUGHOUT THE SCHOOL YEAR WHEN SCHOOL IS NOT IN SESSION; AND PROVIDING AN OPEN MEETINGS CLAUSE.

**Whereas,** the City of Temple Parks and Recreation Department is requesting City Council authorization of an Interlocal Agreement with Academy Independent School District (AISD) to allow the City’s Parks and Recreation Department to administer a day camp called “Bee Camp” on select Fridays throughout the school year when the school district is closed - the camp is projected to operate on approximately 20 Fridays during the 2024-2025 school year;

**Whereas,** AISD will assist with providing supporting staff who will be hired as City of Temple employees to staff the Bee Camp - the Parks and Recreation Department will provide a site leader to oversee the day-to-day operations;

**Whereas,** AISD will reimburse the City at a standard rate per child per day, to be invoiced and paid to the City monthly - this rate will cover the costs of staffing, supplies, and other expenses for running the Bee Camp;

**Whereas,** the term of this Agreement, if approved, will be from July 1, 2024 through the last day of the 2024-2025 school year, at which time both parties may extend or renegotiate the Agreement by mutual consent - either party may terminate this Agreement at any time by providing 30 days’ notice; however, the City can terminate this Agreement immediately if AISD does not provide sufficient staffing to assist with operations of the Bee Camp;

**Whereas,** this Agreement with AISD helps meet the City Council goal of jointly partnering with school districts to provide services and programs;

**Whereas,** Staff recommends Council authorize an Interlocal Agreement with AISD to provide day camps on select Fridays throughout the school year when school is not in session;

**Whereas,** AISD has agreed to waive all facility usage fees during the time the program is being offered, thus allowing the program to be offered at an affordable rate for the participants; and

**Whereas,** the City Council has considered the matter and deems it in the public interest to authorize this action.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:**

**Part 1: Findings.** All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Temple, Texas, and they are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.

**Part 2:** The City Council authorizes an Interlocal Agreement with the Academy Independent School District to provide day camps on select Fridays throughout the school year when school is not in session, and authorizes the City Manager, or her designee, after approval as to form by the City Attorney’s Office, to execute any necessary documents.

**Part 3:** It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
