A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING A REIMBURSEMENT TO TEMPLE & CENTRAL TEXAS RAILWAY, A SUBSIDIARY OF PATRIOT RAIL COMPANY, LLC, FOR RAIL MAINTENANCE EXPENSES IN THE ESTIMATED AMOUNT OF \$79,204.47; AND PROVIDING AN OPEN MEETINGS CLAUSE.

**Whereas,** Temple & Central Texas Railway (TC Rail) identified rail maintenance repairs needed on the track and switches east of Wendland Road, between Wilsonart Drive and Moores Mill Road - the repairs include replacing approximately 250 track ties and 159 switch ties, estimated to total \$81,204.47;

**Whereas,** the City's agreement with TC Rail requires the railway to pay the first \$2,000 of each repair item, so the railway's portion of this repair would total \$2,000 - the City's share of the repairs is estimated at \$79,204.47;

**Whereas,** Staff recommends Council authorize a reimbursement to TC Rail, a subsidiary of Patriot Rail Company, LLC, for rail maintenance expenses in the estimated amount of \$79,204.47;

**Whereas,** funding for this reimbursement to TC Rail in an amount not to exceed \$79,204.47 is available in the Reinvestment Zone No. 1 Financing Plan, Line 56, Account No. 795-9500-531-6514, Project No. 100692; and

**Whereas,** the City Council has considered the matter and deems it in the public interest to authorize this action.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:**

**Part 1: Findings.** All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Temple, Texas, and they are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.

**Part 2:** The City Council authorizes a reimbursement to Temple & Central Texas Railway, a subsidiary of Patriot Rail Company, LLC, for rail maintenance expenses in the estimated amount of \$79,204.47, and authorizes the City Manager, or her designee, after approval as to form by the City Attorney's Office, to execute any necessary documents.

**Part 3:** It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
