A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING THE PURCHASE OF MOBILE AND PORTABLE RADIOS FROM DAILEY & WELLS COMMUNICATIONS, INC. OF SAN ANTONIO, TEXAS IN THE ESTIMATED AMOUNT OF \$446,835.35 AND THE PURCHASE OF INSTALL KITS AND LABOR FOR RADIO SWAPS IN POLICE VEHICLES FROM DANA SAFETY SUPPLY, INC. OF GREENSBORO, NORTH CAROLINA IN THE ESTIMATED AMOUNT OF \$52,250; DECLARING AN OFFICIAL INTENT TO REIMBURSE THE EXPENDITURES WITH THE ISSUANCE OF 2025 LIMITED TAX NOTES; AND PROVIDING AN OPEN MEETINGS CLAUSE.

Whereas, this item will allow for the purchase of mobile and portable radios from Dailey & Wells Communication, Inc. (Dailey & Wells) of San Antonio, Texas, as well as install kits and labor from Dana Safety Supply, Inc. (Dana Safety) of Greensboro, North Carolina for radio swaps in 55 police vehicles as approved in the Fiscal Year 2025 Budget;

Whereas, Dailey & Wells has been awarded Contract No. RA05-21 by the Houston-Galveston Area Council (H-GAC) cooperative and Dana Safety has been awarded Contract No. 240102 by The Interlocal Purchasing System (TIPS) cooperative - Staff is recommending using these contracts for these purchases;

Whereas, contracts awarded by H-GAC and TIPS have been competitively procured and meet the statutory procurement requirements for Texas municipalities - delivery of the radios is expected in one month;

Whereas, Staff recommends Council authorize the purchase of mobile and portable radios from Dailey & Wells in the estimated amount of \$446,835.35 and the purchase of install kits and labor for radio swaps in police vehicles from Dana Safety in the estimated amount of \$52,250, as well as declare an official intent to reimburse the expenditures with the issuance of 2025 Limited Tax Notes;

Whereas, these mobile and portable radios, as well as the install kits and labor for radio swaps, are being funded with the issuance of the 2025 Limited Tax Notes and the City is declaring an official intent to reimburse for these purchases - a budget adjustment will be prepared at the time of the sale to reimburse expenditures incurred prior to the issuance of the limited tax notes; and

Whereas, funding for these purchases from Dailey & Wells and Dana Safety will be available in Account No. 364-2000-521-6224, as follows:

Whereas, the City Council has considered the matter and deems it in the public interest to authorize this action.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:

Part 1: Findings. All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Temple, Texas, and they are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.

Part 2: The City Council authorizes the purchase of mobile and portable radios from Dailey & Wells Communications, Inc. of San Antonio, Texas in the estimated amount of \$446,835.35 and the purchase of install kits and labor for radio swaps in police vehicles from Dana Safety Supply, Inc. of Greensboro, North Carolina in the estimated amount of \$52,250; declares an official intent to reimburse the expenditures with the issuance of 2025 Limited Tax Notes; and authorizes the City Manager, or her designee, after approval as to form by the City Attorney's Office, to execute any necessary documents.

Part 3: It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
