



ABSTRACT 658**, Bell County, Texas, embracing a portion of Lots 2, 3, 4, 5, and 6, Block 46, FREEMAN HEIGHTS ADDITION, an addition in the City of Temple, Bell County, Texas, according to the plat of record in Volume 98, Page 501, Deed Records of Bell County, Texas, and being more particularly described as follows:

BEGINNING at a mag nail with shiner set in asphalt, being the southwest corner of the remainder of said Lot 6, being on the east line of Momma Dog Circle as determined by maps provided by Texas Department of Transportation and the north line of West Avenue G for the southwest corner of the herein described tract;

THENCE, in a northerly direction, with the east line of said Momma Dog Circle, **N 19° 33' 48" E – 238.61'**, to a 5/8" iron rod with cap stamped "ACS" found at the southwest corner of a called 0.0344 Acre Easement and Right-of-Way granted to Oncor Electric Delivery Company in Document No. 2024026006, Official Public Records of Real Property, Bell County, Texas, for the northwest corner of the herein described tract;

THENCE, in an easterly direction, with the south line of said 0.0344 Acre easement, **S 70° 26' 12" E – 23.00'**, to a calculated point, for the northeast corner of the herein described tract;

THENCE, in a southerly direction, **S 19° 33' 48" W – 237.34'**, to a calculated point on the north line of said West Avenue G, for the southeast corner of the herein described tract;

THENCE, in a westerly direction, with the north line of said West Avenue G, **N 73° 35' 12" W – 23.03'**, to the **POINT OF BEGINNING** and containing 0.1257 Acre of Land.
