A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING THE PURCHASE OF AN ANNUAL SOFTWARE SUBSCRIPTION AND MAINTENANCE FROM CENTRALSQUARE TECHNOLOGIES OF LAKE MARY, FLORIDA IN THE ESTIMATED AMOUNT OF \$110,312.38; AND PROVIDING AN OPEN MEETINGS CLAUSE.

Whereas, the City of Temple has used Superion/CentralSquare Technologies (CentralSquare) products for many years and currently uses CentralSquare's H5 software for the following business applications: General Ledger; Accounts Payable; Accounts Receivables; Fixed Assets; Inventory; Purchasing; Cash Receipts; Utility Billing; Business Licenses; Project Accounting; C2G; eLearning; and Reporting;

Whereas, renewal of the Utility Billing and Fusion modules will only be for one month as the City is moving to Muni-Link and InvoiceCloud - the eLearning subscription will be removed due to little to no usage;

Whereas, CentralSquare (previously Superion, LLC) is the sole provider of maintenance for its software - the term of the subscription and maintenance agreement will be October 1, 2024 through September 30, 2025;

Whereas, Staff recommends Council authorize the purchase of an annual software subscription and maintenance from CentralSquare in the estimated amount of \$110,312.38; and

Whereas, funding for the purchase of the H5 software subscription and maintenance from CentralSquare in the estimated amount of \$110,312.38 will be in the Fiscal Year 2025 Budget as follows:

Whereas, the City Council has considered the matter and deems it in the public interest to authorize this action.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:

Part 1: Findings. All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Temple, Texas, and they are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.

Part 2: The City Council authorizes the purchase of an annual software subscription and maintenance from CentralSquare Technologies of Lake Mary, Florida in the estimated amount of \$110,312.38, and authorizes the City Manager, or her designee, after approval as to form by the City Attorney's Office, to execute any necessary documents.

Part 3: It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
