A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, RATIFYING A TRUCK RENTAL AGREEMENT WITH BIG TRUCK RENTAL, INC. OF TAMPA, FLORIDA IN THE ESTIMATED AMOUNT OF \$180,695.50; AND PROVIDING AN OPEN MEETINGS CLAUSE.

Whereas, this truck rental agreement allows for the rental of three front-end loader (FEL) and four automated side loader (ASL) trucks from Big Truck Rental, Inc. of Tampa, Florida for the Solid Waste Division - the rental trucks are needed to supplement ongoing solid waste operations in both the commercial and residential divisions;

Whereas, Staff entered into the agreement in an effort to expedite receipt and operation of the rental vehicles and, as such, Staff is requesting Council's ratification of this truck rental agreement - delivery of the FEL and ASL trucks is expected in July 2024;

Whereas, Big Truck Rental, Inc. has been awarded Contract No. 2019000319 by OMNIA Partners, which Staff utilized for this purchase - contracts awarded by OMNIA Partners have been competitively procured and meet the statutory procurement requirements for Texas municipalities;

Whereas, Staff recommends Council ratify a truck rental agreement with Big Truck Rental, Inc. in the estimated amount of \$180,695.50; and

Whereas, Council is being presented a budget adjustment for approval to appropriate funding in the amount of \$180,695.50 for the truck rental agreement with Big Truck Rental, Inc. - upon approval of the budget adjustment, funding in the amount of \$180,695.50 will be available as follows:

Part 2: The City Council ratifies a truck rental agreement with Big Truck Rental, Inc. of Tampa, Florida in the estimated amount of \$180,695.50 and authorizes the City Manager, or her designee, after approval as to form by the City Attorney's Office, to execute any necessary documents.

Part 3: It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
