A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING A SERVICES AGREEMENT WITH MULTIVOLT ELECTRIC, INC. OF TEMPLE, TEXAS FOR THE MAINTENANCE AND REPAIR OF THE TELEMETRY AND SUPERVISORY CONTROL AND DATA ACQUISITION SYSTEMS IN THE ESTIMATED AMOUNT OF \$50,000; AND PROVIDING AN OPEN MEETINGS CLAUSE.

Whereas, authorization of this services agreement with MultiVolt Electric, Inc. (MultiVolt) of Temple, Texas will provide for as-needed telemetry and supervisory control and data acquisition (SCADA) services for systems installed within the City of Temple;

Whereas, the telemetry and SCADA systems assist in the management of the City's water distribution system at the Water Treatment Plant - in addition, the City has telemetry and SCADA systems implemented to help manage the wastewater collection system and traffic control system;

Whereas, Request for Proposals No. 51-01-25 was issued to procure telemetry and SCADA maintenance and repair services and two proposals were received from Logos Automation, LLC of Chattanooga, Tennessee and MultiVolt - an evaluation committee comprised of Public Works Staff reviewed and scored proposals based on the stated evaluation criteria: overall pricing, approach for providing services, reputation, and availability of qualified staff;

Whereas, City Staff determined that MultiVolt will provide the best value for the City, as shown in the proposal tabulation, attached hereto and incorporated herein as Exhibit A - the initial term of the agreement will be October 1, 2024 through September 30, 2025, with the option to renew the agreement for four additional one-year periods, if mutually agreed to by both parties;

Whereas, Staff recommends Council authorize a services agreement with MultiVolt for the maintenance and repair of the telemetry and SCADA systems in the estimated amount of \$50,000;

Whereas, funding for a services agreement with MultiVolt is available in the estimated amount of \$18,000 in Account No. 520-5100-535-2319 and the remaining \$32,000 is reserved for additional telemetry and SCADA services or equipment purchases by various departments on an as-needed basis - the estimated annual expenditure of \$50,000 is based on historical expenditures; and

Whereas, the City Council has considered the matter and deems it in the public interest to authorize this action.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:

Part 1: Findings. All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Temple, Texas, and they are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.

Part 2: The City Council authorizes a services agreement with MultiVolt Electric, Inc. of Temple for the maintenance and repair of the telemetry and supervisory control and data acquisition systems in the estimated amount of \$50,000, and authorizes the City Manager, or her designee, after approval as to form by the City Attorney's Office, to execute any necessary documents.

Part 3: It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
