A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING THE PURCHASE OF ONE CHEVROLET MEDIUM DUTY CREW CAB AND CHASSIS WITH UTILITY FLATBED FROM DON RINGLER CHEVROLET FLEET AND COMMERCIAL OF TEMPLE, TEXAS IN THE ESTIMATED AMOUNT OF \$96,585.38; AND PROVIDING AN OPEN MEETINGS CLAUSE.

**Whereas,** approval of this item will allow for the purchase of one Chevrolet medium duty Crew Cab and Chassis with utility flatbed from Don Ringler Chevrolet Fleet and Commercial (Don Ringler) of Temple, Texas as approved in the Fiscal Year 2024 Budget - the purchase of this Fire Department vehicle, which is expected to be delivered in the winter of 2024, is a replacement of Asset No. 13529, a 2012 Ford F550 squad, and will replace an aging apparatus as well as improve the City's response capabilities;

**Whereas,** Don Ringler has been awarded Contract Nos. 230404 and 230802 by The Interlocal Purchasing System (TIPS), which Staff is recommending using for this purchase - contracts awarded by TIPS have been competitively procured and meet the statutory procurement requirements for Texas municipalities;

**Whereas,** Staff recommends Council authorize the purchase of one Chevrolet medium duty Crew Cab and Chassis with utility flatbed from Don Ringler in the estimated amount of \$96,585.38;

**Whereas,** funding for the purchase of a Fire Department squad vehicle with Don Ringler in the estimated amount of \$96,585.38 is available in Account No. 361-2200-522-6222, Project No. 103239 - remaining project funds will be utilized to upfit the vehicle with proper lighting and other emergency response and firefighting equipment; and

**Whereas,** the City Council has considered the matter and deems it in the public interest to authorize this action.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:**

**Part 1: Findings.** All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Temple, Texas, and they are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.

**Part 2:** The City Council authorizes the purchase of one Chevrolet medium duty Crew Cab and Chassis with utility flatbed from Don Ringler Chevrolet Fleet and Commercial of Temple, Texas in the estimated amount of \$96,585.38, and authorizes the City Manager, or her designee, after approval as to form by the City Attorney's Office, to execute any necessary documents.

**Part 3:** It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
