A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING A CONSTRUCTION CONTRACT WITH B-CORP UTILITIES, LLC OF GATESVILLE, TEXAS FOR THE CONSTRUCTION OF THE SOUTH 10TH STREET WATERLINE IN THE ESTIMATED AMOUNT OF \$433,703.26; AND PROVIDING AN OPEN MEETINGS CLAUSE.

Whereas, approval of this item will allow for the execution of a construction contract with B-Corp Utilities, LLC (B-Corp) of Gatesville, Texas for the construction of the 10th Street Waterline - as shown on the Bid Tabulation for Bid No. 52-01-24, attached hereto and incorporated herein as Exhibit A, the City received three bids for this project on May 28, 2024, with base bids ranging from a low of \$433,703.26 to a high of \$882,325;

Whereas, the project replaces and upsizes an existing waterline that is in poor condition as well as reroutes older services to standard locations - a small section of sewer main will also be relocated as part of this project;

Whereas, B-Corp was the low responsive bidder, as indicated on the Engineer’s Letter of Recommendation, attached hereto and incorporated herein as Exhibit B - it is the recommendation of Clark Associates and the City Staff to award the bid as outlined in the Bid Tabulation and Engineer’s Letter of Recommendation;

Whereas, construction of this project is expected to be complete by November 1, 2024, based on 60 designated construction days;

Whereas, Staff recommends Council authorize a construction contract with B-Corp for the construction of the South 10th Street Waterline in the estimated amount of \$433,703.26; and

Whereas, funding for the construction contract with B-Corp for the construction of 10th Street Waterline in the amount of \$433,703.26 is available in Project No. 103125 as follows:

Part 1: Findings. All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Temple, Texas, and they are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.

Part 2: The City Council authorizes a construction contract with B-Corp Utilities, LLC of Gatesville, Texas for the construction of the South 10th Street Waterline in the estimated amount of \$433,703.26, and authorizes the City Manager, or her designee, after approval as to form by the City Attorney’s Office, to execute any necessary documents.

Part 3: It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
