<u>ITEM DESCRIPTION:</u> Consider adopting a resolution authorizing an annual purchase agreement for hot mix asphalt for FY 2021 with Texas Materials Group, Inc. of Cedar Park, in the estimated annual amount of \$87,750.

BACKGROUND: Authorization of the purchase agreement with Texas Materials Group, Inc will provide for the purchase of hot mix asphalt for the City's Street Department during FY 2021 at a cost of \$58.50 per ton.

As shown on the attached bid tabulation, on July 30, 2020, the City received two bids for the purchase of hot mix asphalt. The invitation to bid specified that the award of the purchase agreement would be based on 'best value' as allowed by the Local Government Code Chapter 252. Accordingly, a staff committee comprised of employees from the Street Department, whom are the primary users of the agreement, met to discuss the pick-up plant location and pricing offered by both vendors. It was a unanimous consensus of the committee that Texas Materials Group, Inc, offered the best value. Staff have been pleased with the service provided by Texas Materials Group, Inc over the years, and the price offered is a good value.

The proposed agreement will commence October 1, 2020 and go through September 30, 2021. The agreement will provide for four additional one-year periods, if agreed to by the City and Texas Materials Group, Inc.
