<u>ITEM DESCRIPTION:</u> Consider adopting a resolution authorizing a professional services agreement with Kasberg, Patrick & Associates, LP of Temple for final design and bidding phase services required for the Avenue G Pump Station Improvement project in the amount of \$345,250.

BACKGROUND: Approval of this item will allow for the execution of a professional services agreement with Kasberg, Patrick & Associates, LP (KPA) for final design and bidding phase services related to the Avenue G Pump Station Improvements.

The Avenue G Pump Station, built in 1935, is a critical component of the City of Temple's water system and is the only supply for the 876 Pressure Plane, which encompasses the middle portion of the City and extends to the north CCN boundary. The Avenue G Pump Station supplies water to the West Park, Nugent, 25th Street, and Taylor Road Elevated Storage Tanks. On June 18, 2020, Council authorized KPA to perform Preliminary Engineering services for the Ave G Pump Station Improvements. The scope of services of this new design contract is based on the recommendations from the Preliminary Engineering Report (PER) dated January 15, 2021.

As identified in the attached engineer's proposal, KPA will be providing the following professional services:

Task 1 – Geotechnical Investigation	\$	5,400
Task 2 – Final Design		
A. Civil Design	\$1	98,500
B. Electrical/SCADA/HVAC Design	\$	91,580
C. Structural Design	\$	33,100

In accordance with Texas Government Code Chapter 2254, Request for Qualifications (RFQ) #13-14-20 was issued to procure professional engineering services. KPA was selected from the City's prequalified list of engineering firms based on their demonstrated competence and qualifications to perform similar projects.

The engineer's preliminary opinion of probable construction cost for this project is \$4,350,000.

Design of this project is expected to take 270 calendar days from the Notice to Proceed.
