A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING THE PURCHASE OF EIGHT VEHICLES, IN THE TOTAL AMOUNT OF \$278,570, FROM THE FOLLOWING VENDORS: SEVEN PICKUP TRUCKS FROM RANDALL REED'S PLANET FORD 635 OF GARLAND, TEXAS AND ONE PICKUP TRUCK FROM CALDWELL COUNTRY FORD OF ROCKDALE, TEXAS; AND PROVIDING AN OPEN MEETINGS CLAUSE.

Whereas, on March 4, 2021, Council authorized the rejection of the original bids for the purchase of these vehicles to allow Staff the opportunity to re-bid these vehicles to include all-weather capabilities due to the lack of 4x4 City vehicles available during Winter Storm Uri;

Whereas, approval of these truck purchases will allow for the replacement of eight older 4x2 vehicles within the City's fleet with 4x4 vehicles that will have the ability to serve community needs in inclement weather situations - even though these vehicles will be assigned to the department defined in the "Description" column below, in the case of inclement weather, these vehicles may be assigned to other departments to best fulfill the needs of our community;

Whereas, on April 6, 2021, eight vendors submitted pricing on two independent bids - Staff recommends Council authorize the purchase of eight vehicles from the following vendors and as detailed more fully below:

- Seven ½-ton, 4x4 pickup trucks from Randall Reed's Planet Ford 635 of Garland, Texas for \$226,990; and
- One 1-ton, 4x4 pickup truck from Caldwell Country Ford of Rockdale, Texas for \$51,580;

Whereas, the recommended award of bids are as follows:

1) Staff recommends award of Bid A for seven 1/2-ton light duty 4x4 full-size regular cab pick-ups to Randall Reed's Planet Ford 635. The extended 5-year, 100,000-mile warranty is desired for Metering assets as they travel in excess of 15,000 miles per year.
