A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING A THREE-YEAR AGREEMENT FOR THE RENTAL/LEASE OF NON-CIVIL UNIFORMS AND FLOOR MATS WITH CINTAS CORPORATION OF ROUND ROCK, TEXAS IN THE ESTIMATED ANNUAL AMOUNT OF \$75,000, FOR AN ESTIMATED TOTAL CONTRACT VALUE OF \$225,000; AND PROVIDING AN OPEN MEETINGS CLAUSE.

**Whereas**, this item will allow for a three-year agreement for the rental/lease of non-civil uniforms and floor mats with Cintas Corporation - City departments such as Public Works divisions, Metering, Parks & Recreation, Library, and Facility Services utilize uniform services in order for the public to easily identify City of Temple employees and several departments with high traffic also rent floor mats;

**Whereas**, Cintas holds the current uniform and mat service agreement which will expire on July 19, 2022 - Purchasing issued a request for quotes utilizing cooperative contracts to three vendors including Aramark, Cintas, and UniFirst;

**Whereas**, responses were reviewed with user departments who decided that Cintas will provide the best value to the City based on pricing, process and timeline to transition to a new agreement, reputation, and experience - the new agreement will commence on July 20, 2022 and continue through July 19, 2025 which can be extended two additional one-year periods, if agreeable to both parties;

**Whereas**, Cintas Corporation has been awarded OMNIA Partners Contract No. R-BB-19002, which staff is recommending utilizing for these services - contracts awarded through OMNIA Partners have been competitively procured and meet the statutory procurement requirements for Texas municipalities;

**Whereas**, funding is included in the adopted fiscal year 2022 Budget for each department that utilizes the agreement - the fiscal years 2023 - 2025 Proposed Budgets will include funding for the uniform and mat services from Cintas Corporation; and

**Whereas**, the City Council has considered the matter and deems it in the public interest to authorize this action.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:**

**Part 1: Findings.** All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Temple, Texas, and they are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.

**Part 2:** The City Council authorizes the City Manager, or her designee, after approval as to form by the City Attorney's office, to execute a three-year agreement for the rental/lease of non-civil uniforms and floor mats with Cintas Corporation of Round Rock, Texas in the estimated annual amount of \$75,000, for an estimated total contract value of \$225,000.

**Part 3:** It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
